



FIGURE 4.1 The Growth of the Legal Profession and U.S. Population

Distribution of Full-Time Salaries — Class of 2006





Bates v. State Bar of Arizona (1977) Until 1977, most states prohibited attorneys from advertising. In Bates, the U.S. Sup. Ct. found that the First Amendment free speech interests of lawyer advertisers were greater than suppression of "unnecessary" litigation and maintenance of profession's image.

How Often Do Americans Use Attorneys?

- As the next two slides show, people are relatively unlikely to go to attorneys and do so after attempting other solutions





FIGURE 7.1 The Development and Resolution of Disputes

FIGURE 10.1 The Disputing Pyramid for Civil Cases






Gray Bars = Moderate Income/ White Bars are Low Income

FIGURE 5: LAWYER USE, ABA LEGAL NEEDS STUDY (1993)




















