## Answer all of the following five questions.

- 1. [7 points] Show with a diagram that the following two statements are true:
  - (a) An unregulated monopolist may produce more pollution than is socially optimal.
  - (b) An unregulated monopolist may produce less pollution than is socially optimal.
- 2. [6 points] By drawing two diagrams, contrast an optimal Pigouvian tax on output with an optimal Pigouvian tax on pollution.
- 3. [7 points] Tell me everything you know about Figure 1.
- 4. [6 points] On p. 129 of your textbook, the authors write that

...economic theorists tend to dispute that WTP and WTA can differ so much simply because the theory says that they ought not to differ (and hence there must be something wrong with the empirical studies).

Critically evaluate this passage.

5. [7 points] Could an ecocentric philosophy be the outcome of a Rawlsian/contractarian theory of justice in which the moral reference class includes more than just human beings? Why or why not?


